SPECIAL ORDINANCE NO. S- 63-11

AN ORDINANCE approving GENERAL OPEN CUT SEWERS RES. #2201-2009, W.O. #75395 between T-E INCORPORATED and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the GENERAL OPEN CUT SEWERS RES. #2201-2009, W.O. #75395 by and between T-E INCORPORATED and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for Approx. 585 LF of sewer excavation/replacement, 83 LF of sewer point repairs and 5 manhole replacement by means of open-cut excavation to the City as described by project drawings and specifications. Alternates include an additional of 487 LF of sewer excavation/replacement, and 1 manhole replacement by means of open-cut excavation;

involving a total cost of TWO HUNDRED NINETY-EIGHT THOUSAND, FIVE HUNDRED AND NO/100 DOLLARS - (\$298,500.00).

SECTION 2. Prior Approval has been requested from Common Council on JANUARY 25, 2011. Said copy is on file in the Office of the City Clerk and made available for public inspection, according to law.
