12 SEPARATION; RES. #2343-2010, W.O. #75494 by and between MILLER
13 CONTRACTING GROUP and the City of Fort Wayne, Indiana, in connection
14 with the Board of Public Works, is hereby ratified, and affirmed and approved
15 in all respects, respectfully for:

16 All labor, insurance, material, equipment, tools, power,
17 transportation, miscellaneous equipment, etc., necessary
18 for: the construction of approximately 4,200 LF of 8, 12, 15
19 & 24-inch storm sewers with all appurtenant manholes and
20 inlets structures associated with sewer separation along
21 Pontiac St., Oxford St., Drexel Ave., Redwood Ave., and
22 Shadybrook Dr.;

23 involving a total cost of SEVEN HUNDRED FIFTY-TWO THOUSAND, ONE
24 HUNDRED AND 25/100 DOLLARS - (\$752,100.25). A copy said Contract is
25 on file with the Office of the City Clerk and made available for public
26 inspection, according to law.
