3 **AN ORDINANCE of the Common Council fixing,**
4 **establishing and ratifying compensation for**
5 **certain City Utilities employees of the City of**

10 **WHEREAS,** this Council is required to approve all collective
11 bargaining decisions with regard to annual pay and monetary fringe benefits;
12 and

13 **WHEREAS,** an agreement has been reached by and between
14 the City of Fort Wayne, Indiana, and the INTERNATIONAL UNION OF
15 OPERATING ENGINEERS, LOCAL UNION NO. 19/399 (CITY UTILITIES) –
16 City Utilities – through collective bargaining as authorized and envisioned by
17 the City's ordinances; and

18 **WHEREAS,** said agreement is for four (4) years (2010, 2011,
19 2012 and 2013), but pursuant to Indiana law, the compensation provided for
20 therein must be annually ratified; and

21 **WHEREAS,** this ordinance is necessary to ratify, fix and
22 establish such compensation for the year 2011 for said **City Utilities**
23 employees of the City of Fort Wayne, Indiana, represented by the
24 INTERNATIONAL UNION OF OPERATING ENGINEERS, LOCAL UNION
25 NO. 19/399 (CITY UTILITIES) – and to approve the other provisions of said
26 agreement.
