2 **SPECIAL ORDINANCE NO. S- 97-11**

3 AN ORDINANCE of the Common Council fixing,  
4 establishing and ratifying compensation for certain  
5 City employees represented by The Fort Wayne  
6 Professional Fire Fighters Union Local #124, Inc.

7 **WHEREAS**, Common Council previously passed Special Ordinance No.S-85-  
8 09 approving collective bargaining agreement for employees of the City of Fort Wayne, Indiana,  
9 represented by the Fort Wayne Professional Fire Fighters Union Local #124; and


10 **WHEREAS**, said agreement is for three (3) years, but pursuant to Indiana law,  
11 the compensation provided for therein must be annually ratified; and

12 **WHEREAS**, this ordinance is necessary to ratify, fix and establish such  
13 compensation for the year 2011 for said employees of the City of Fort Wayne, Indiana  
14 represented by the Fort Wayne Professional Fire Fighters Union Local #124.

15 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF  
16 THE CITY OF FORT WAYNE, INDIANA:**

17 **SECTION 1.** The 2011 Wage Agreement by between the Fort Wayne  
18 Professional Fire Fighters Union Local #124 and the City of Fort Wayne, a copy of which is on  
19 file in the Office of the City Clerk and available for public inspection, is hereby approved and  
20 ratified in all respects

21 **SECTION 2.** This Ordinance shall be in full force and effect from and after its  
22 passage and any and all necessary approvals by the Mayor.
