16 between HIPSKIND CONCRETE and the City of Fort Wayne, Indiana, in
17 connection with the Board of Public Works, is hereby ratified, and affirmed and
18 approved in all respects, respectfully for:

19 All labor, insurance, material, equipment, tools, power,
20 transportation, miscellaneous equipment, etc., necessary for
21 East Washington Blvd. from University St. to Clay St. by
22 reconstructing the existing curbface sidewalk with new curbing,
23 sidewalks, and a parkstrip. Also reconstructing the existing
24 sidewalks and curb ramps as needed:


25 involving a total cost of ONE HUNDRED SIX THOUSAND, SEVEN
