14 PURCHASE OF BITUMINOUS MATERIAL between the City of Fort Wayne,
15 by and through its Department of Purchasing and BIT-MAT PRODUCTS,
16 ASPHALT MATERIAL, AND K-TECH SPECIALTY for the STREET
17 DEPARTMENT, respectfully for:

18 purchase of bituminous materials, required for the production of
19 asphalt used for the construction and maintenance of city
20 streets, including paving, chip and seal, resurfacing, crack
21 sealing, patching potholes and utility cut restorations;

22 involving a total cost of SEVEN HUNDRED SIXTY THOUSAND AND NO/100
23 DOLLARS - (\$760,000.00) - (BIT-MAT - \$50,000.00; ASPHALT -
24 \$140,000.00; K-TECH - \$570,000.00) all as more particularly set forth in said
25 ITB #3349 - ANNUAL CONTRACT FOR THE PURCHASE OF BITUMINOUS
26 MATERIAL which is on file in the Office of the Department of Purchasing, and
27 is by reference incorporated herein, made a part hereof, and is hereby in all
28 things ratified, confirmed and approved.


