16 AND EJ PRESCOTT for the WPC MAINTENANCE/ STORM WATER
17 MAINTENANCE DEPARTMENTS, respectfully for:

18 purchase of materials used in the repair/replacements of
19 manholes, catch basins, inlets, pipe, etc. all found in the
20 sanitary, combined and storm sewer collections systems;


21 involving a total cost of ONE HUNDRED SEVENTY THOUSAND AND NO/100
22 DOLLARS - (\$170,000.00) - (MIDWEST - \$120,000.00; HD - \$30,000.00; EJ
23 PRESCOTT - \$20,000.00) all as more particularly set forth in said ITB #3341 -
24 ANNUAL REQUIREMENTS FOR SEWER CONSTRUCTION MATERIAL
25 which is on file in the Office of the Department of Purchasing, and is by
26 reference incorporated herein, made a part hereof, and is hereby in all things
27 ratified, confirmed and approved.
