15 REPAIR - WORK ORDER NO. 12238 by and between GARCIA CONCRETE
16 CORP. and the City of Fort Wayne, Indiana, in connection with the Board of
17 Public Works, is hereby ratified, and affirmed and approved in all respects,
18 respectfully for:

19 All labor, insurance, material, equipment, tools, power,
20 transportation, miscellaneous equipment, etc., necessary for
21 Victoria Park Neighborhood, Embassy Drive from S. Anthony
22 Blvd. to Salisbury Drive, and Derbyshire Drive from Gladstone
23 Drive to Montford Drive, by reconstruction of 1550 +/- centerline
24 feet of the concrete roadway, I.E. partial concrete pavement
25 replacement; which includes integral curbs, under-drain,
26 concrete corner walk and ramps, topsoil and hydro-seed
27 restoration:

28 involving a total cost of ONE HUNDRED EIGHTY-EIGHT THOUSAND, ONE
29 HUNDRED NINETEEN AND 50/100 DOLLARS - (\$188,119.50). A copy said
30 Contract is on file with the Office of the City Clerk and made available for
public inspection, according to law.
