9 **SECTION 1.** That the RFP #7314-2011-RESURFACING  
10 PACKAGE B-2011: WORK ORDER NO. 12220 by and between E&B  
11 PAVING and the City of Fort Wayne, Indiana, in connection with the Board of  
12 Public Works, is hereby ratified, and affirmed and approved in all respects,  
13 respectfully for:

15 All labor, insurance, material, equipment, tools, power,  
16 transportation, miscellaneous equipment, etc., necessary for  
17 Resurfacing Package focuses on various streets in the 1st, 2nd  
18 and 3rd Districts. Over seven (7) centerline miles of roadway  
milling and resurfacing represented in this package. 2.3 miles to  
19 resurface in the 1st District; 2.5 miles in the 2nd District; and  
2.7 miles in the 3<sup>rd</sup> District. All locations will experience either  
20 surface or surface and binder course replacement, some  
pavement markings, signal loop work, castings and valves  
21 adjusted to grade:

22 involving a total cost of EIGHT HUNDRED SIXTY-FOUR THOUSAND, SIX  
23 HUNDRED THREE AND 00/100 DOLLARS - (\$864,603.00). A copy said  
24 Contract is on file with the Office of the City Clerk and made available for  
25 public inspection, according to law.
