SPECIAL ORDINANCE NO. S-117-11

AN ORDINANCE approving IMPROVEMENT RESOLUTION NO. 7313-11 - WORK ORDER NO. 12233 DUPONT ROAD E. SIDEWALK AND TRAIL IMPROVEMENTS between HIPSKIND CONCRETE and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the IMPROVEMENT RESOLUTION NO. 7313-11 - WORK ORDER NO. 12233 DUPONT ROAD E. SIDEWALK AND TRAIL IMPROVEMENTS by and between HIPSKIND CONCRETE and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for East Dupont Road from 800 feet west of Auburn Road to the I-69 Right-of-Way by installing an 8' wide concrete trail and by improving the intersections of Auburn Road and Dupont Road and Longwood Dr and Dupont Road with ADA ramps and pedestrian crossing signals and markings:

involving a total cost of ONE HUNDRED SEVENTY-TWO THOUSAND, TWO HUNDRED ELEVEN AND 75/100 DOLLARS - (\$172,211.75). A copy said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.
