11 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
12 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**


13 **SECTION 1.** That the CONSTRUCTION CONTRACT FOR CS
14 POND 1 - SEDIMENT DISPOSAL PHASE 1 - RES. #2409-2011, W.O.
15 #75642 by and between NATIONAL SALVAGE & SERVICE CORP. and the
16 City of Fort Wayne, Indiana, in connection with the Board of Public Works, is
17 hereby ratified, and affirmed and approved in all respects, respectfully for:

18 All labor, insurance, material, equipment, tools, power,
19 transportation, miscellaneous equipment, etc., necessary for
20 Removal and management/disposal of Phase I sediment spoils
21 that were dredged from CS Pond No. 1 and placed in Geotubes.
22 The estimated quantity of material requiring disposal is
23 approximately 26,000 cubic yards. All sediments shall be hauled
24 to the City's Biosolids Management facility at 6202 Lake Avenue
25 in Ft. Wayne:

26 involving a total cost of THREE HUNDRED THREE THOUSAND, SIX
27 HUNDRED FIFTY AND 00/100 DOLLARS - (\$303,650.00). A copy said
28 Contract is on file with the Office of the City Clerk and made available for
29 public inspection, according to law.



SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.


