11 COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**


12 **SECTION 1.** That the CONSTRUCTION CONTRACT FOR
13 WPCP DIGESTER IMPROVEMENTS STRUCTURAL AND ELECTRICAL
14 BUILDING - RES. #2188-2009, W.O. #75386 by and between HAGERMAN
15 INC. and the City of Fort Wayne, Indiana, in connection with the Board of
16 Public Works, is hereby ratified, and affirmed and approved in all respects,
17 respectfully for:

18 All labor, insurance, material, equipment, tools, power,
19 transportation, miscellaneous equipment, etc., necessary for
20 WPCP DIGESTER IMPROVEMENTS STRUCTURAL AND
21 ELECTRICAL BUILDING AS FOLLOWS: construction of the
22 addition of a new electrical room to serve the digester complex,
23 the addition of a new high strength waste receiving pump station,
24 the addition of new emergency egresses from the digester pipe
25 gallery, modifications to fuel supply of boilers and the digester
26 flare pilot, removal of an underground fuel storage tank, and the
27 associated piping, electrical, I&C and HVAC systems:

28 involving a total cost of FIVE MILLION, SIX HUNDRED SEVENTY-TWO
29 THOUSAND AND 50/100 DOLLARS - (\$5,672,000.50). A copy said Contract
30 is on file with the Office of the City Clerk and made available for public
inspection, according to law.


