18 transportation, miscellaneous equipment, etc., necessary for
19 Hazelett/Rothman Septic Elimination - Installation of 4388 LF of 8"
20 PVC gravity open cut sewers and 1187 LF of 2" HPDE directional
21 drill low pressure sewers along with 10 homes on grinder pumps
22 outside of the right of way:



23 involving a total cost of FOUR HUNDRED EIGHTY-TWO THOUSAND, EIGHT
