22 Filtration Plant North-South Reservoir:

23 involving a total cost of ONE MILLION, FIVE HUNDRED FIFTY-SEVEN
24 THOUSAND, THREE HUNDRED SIXTY-FIVE AND 00/100 DOLLARS -
