9 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL**

11 **SECTION 1.** That ITB #3372-PURCHASE AND PLANTING OF
12 STREET TREES between the City of Fort Wayne, by and through its
13 Department of Purchasing and SHADE TREES UNLIMITED for the PARKS
14 AND RECREATION DEAPRTMENT, respectfully for:

15 purchase and planting of trees in the City right-of-way as well as
16 trees being planted in the Parks;

17 involving a total cost of THREE HUNDRED TWO THOUSAND, ONE
18 HUNDRED EIGHTY-NINE AND 00/100 DOLLARS - (\$302,189.00) all as
19 more particularly set forth in said ITB #3372-PURCHASE AND PLANTING OF
20 STREET TREES which is on file in the Office of the Department of
21 Purchasing, and is by reference incorporated herein, made a part hereof, and
22 is hereby in all things ratified, confirmed and approved.
