16 PUMP STATION AND MISCELLANEOUS WPC PLANT/PONDS
17 IMPROVEMENTS, CM AND RPR SERVICES DURING CONSTRUCTION -
18 RES. #2283-2010, W.O. #75449 by and between AMERICAN
19 STRUCTUREPOINT and the City of Fort Wayne, Indiana, in connection with
20 the Board of Public Works, is hereby ratified, and affirmed and approved in all
21 respects, respectfully for:

22 All labor, insurance, material, equipment, tools, power,
23 transportation, miscellaneous equipment, etc., necessary for
24 Resident Project Representative services in support of
25 Construction Management services during construction that
26 include coordination with plant activities and staff, daily
27 inspections, constructions schedule management and
28 coordination, construction progress meetings, administrative
29 duties, coordination of training services, record drawing review,
30 and other general construction management tasks. In addition,
the EPA consent decree requires project record documentation
as well as compliance with mandatory deadlines:

2 involving a total cost of TWO HUNDRED EIGHTY THOUSAND AND 00/100
3 DOLLARS – (\$280,000.00). A copy said Contract is on file with the Office of
4 the City Clerk and made available for public inspection, according to law.

5 **SECTION 2.** That this Ordinance shall be in full force and effect
6 from and after its passage and any and all necessary approval by the Mayor.
