12 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
13 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

14 **SECTION 1.** That the CONTRACT FOR COMBINED SEWAGE
15 PUMP STATION AND MISCELLANEOUS WPC PLANT/PONDS
16 IMPROVEMENTS, CM AND RPR SERVICES DURING CONSTRUCTION by
17 and between GAI CONSULTANTS RES. #2283-2010, W.O. #75449 and the
18 City of Fort Wayne, Indiana, in connection with the Board of Public Works, is
19 hereby ratified, and affirmed and approved in all respects, respectfully for:

20 All labor, insurance, material, equipment, tools, power,
21 transportation, miscellaneous equipment, etc., necessary for
22 Resident Project Representative services in support of
23 Construction Management services during construction that
24 include coordination with plant activities and staff, daily
25 inspections, constructions schedule management and
26 coordination, construction progress meetings, administrative
27 duties, coordination of training services, record drawing review,
28 and other general construction management tasks. In addition,
29 the EPA consent decree requires project record documentation
30 as well as compliance with mandatory deadlines:

2 involving a total cost of FOUR HUNDRED TWENTY-ONE THOUSAND,
3 SEVEN HUNDRED TWENTY-THREE AND 00/100 DOLLARS - (\$421,723.00).
4 A copy said Contract is on file with the Office of the City Clerk and made
5 available for public inspection, according to law.

6 **SECTION 2.** That this Ordinance shall be in full force and effect
7 from and after its passage and any and all necessary approval by the Mayor.
