8 and the City of Fort Wayne, Indiana, in connection

10 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
11 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

12 **SECTION 1.** That the (CONTRACT A) WPCP COMBINED
13 SEWAGE PUMP STATION AND SCREENINGS BUILDING
14 IMPROVEMENTS. RES. #2283-2010, W.O. #75449 by and between
15 WEIGAND CONSTRUCTION and the City of Fort Wayne, Indiana, in
16 connection with the Board of Public Works, is hereby ratified, and affirmed and
17 approved in all respects, respectfully for:

18 All labor, insurance, material, equipment, tools, power,
19 transportation, miscellaneous equipment, etc., necessary for

20 Construction of wastewater pump and treatment facilities
21 including sitework, yard piping, buried cast-in-place and precast
22 concrete wastewater conveyance conduits, structural and
23 architectural Work, process piping, pumps, and other equipment,
24 plumbing Work, heating, ventilation, and air conditioning Work,
25 electrical Work, and instrumentation and control Work. The
26 Project includes a major upgrade and expansion of the existing
27 combined sewage pump station (CSPS), construction of a new
28 wastewater screen facility, and associated support facilities:

29 involving a total cost of TWENTY-ONE MILLION, SEVEN HUNDRED FIFTY-
30 EIGHT THOUSAND, TWO HUNDRED SIXTEEN AND 00/100 DOLLARS -
(\$21,758,216.00). A copy said Contract is on file with the Office of the City
