12 Works, is hereby ratified, and affirmed and approved in all respects,

16 transportation, miscellaneous equipment, etc., necessary for
17 Swift Interceptor Relief Sewer: installation of approximately
18 6,520 LF of 30" PVC sanitary sewer for the purpose of relieving
wet-weather related capacity issues in the existing Swift
Interceptor;


19 involving a total cost of ONE MILLION, EIGHT HUNDRED FOURTEEN
