4 **AN ORDINANCE ESTABLISHING THE CSQ**  
5 **PARKING FUND.**

6 **WHEREAS**, the City of Fort Wayne and Allen County co-located  
7 operations at 200 E. Berry Street; and,

8 **WHEREAS**, there were additional parking options for employees as  
9 well as City and County owned vehicles; and,

10 **WHEREAS**, the City has sole responsibility for the administration and  
11 management of the additional parking options; and,

12 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**  
13 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**


14 **SECTION 1.** The CSQ Parking Fund shall be established for the  
15 purpose of accounting for the receipts and payments related to the rental of  
16 the CSQ parking options.

17 **SECTION 2.** Balances remaining at year end may remain in those  
18 accounts and carry forward into the following year for appropriate use  
19 without additional approval required by the Common Council.

20 **SECTION 3.** That this Ordinance shall be in full force and effect from  
21 and after its passage and any and all necessary approval by the Mayor.
