11 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
12 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

13 **SECTION 1.** That the CONSTRUCTION CONTRACT FOR
14 THREE RIVERS FILTRATION PLANT (TRFP) UV DISINFECTION PROJECT
15 (COST-PLUS) AND (GUARANTEED SAVINGS CONTRACT) by and
16 between KOKOSING CONSTRUCTION COMPANY and the City of Fort
17 Wayne, Indiana, in connection with the Board of Public Works, is hereby
18 ratified, and affirmed and approved in all respects, respectfully for:

19 All labor, insurance, material, equipment, tools, power,
20 transportation, miscellaneous equipment, etc., necessary for
21 Construction of potable water facilities including sitework, yard
22 piping, structural, architectural, process-mechanical pumping
23 equipment, gate equipment, and piping plumbing, heating,
24 ventilation, air conditioning, electrical, and instrumentation and
25 control. Structural work for new structures and buried piping
26 includes bored cast-in-place concrete pile foundation;

27 involving a total cost of NINETEEN MILLION, TWO HUNDRED THIRTY-SIX
28 THOUSAND, THREE HUNDRED TEN AND 00/100 DOLLARS
29 (\$19,236,310.00).

30 **SECTION 2.** Prior Approval has been requested from Common
Council on DECEMBER 13, 2011. Said copy is on file in the Office of the City
