3 **AN ORDINANCE OF THE COMMON**
4 **COUNCIL RATIFYING A COLLECTIVE**
5 **BARGAINING AGREEMENT FOR POLICE**
6 **OFFICERS REPRESENTED BY THE FORT**
7 **WAYNE PATROLMEN'S BENEVOLENT**
8 **ASSOCIATION, INC. FOR THE YEARS 2010,**
9 **2011 AND 2012.**

10 **WHEREAS**, this Council is required to approve all collective
11 bargaining agreements with regard to compensation including annual pay
12 and monetary fringe benefits; and

13 **WHEREAS**, such compensation for employees of the City of Fort
14 Wayne, Indiana, represented by The Fort Wayne Patrolmen's Benevolent
15 Association, Inc. is the subject of an agreement reached by and between the
16 City and the Fort Wayne Patrolmen's Benevolent Associate, Inc. in
17 accordance with the collective bargaining provisions in City Code: and

18 **WHEREAS**, said agreement is for four (4) years, but pursuant to
19 Indiana law, the compensation provided for therein must be annual ratified;
20 and

21 **WHEREAS**, the Common Council desires to express its approval of
22 the agreement and the compensation packages for the years 2010 and 2011;
23 and

24 **WHEREAS**, this ordinance is necessary to ratify, fix and establish
25 such compensation for said employees represented by the Fort Wayne
26 Patrolmen's Benevolent Association, Inc. for 2010 and 2011.

27 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
28 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

29 **SECTION 1.** The 2010, 2011 and 2012 agreement by and between
30 the Fort Wayne Patrolmen's Benevolent Associate, Inc. and the City of Fort
Wayne, a copy of which is on file in the office of the City Clerk and available




for public inspection, is hereby approved and ratified in all respects, including the compensation package for 2010 and 2011.
