14 **SECTION 1.** That the PROFESSIONAL SERVICES
15 AGREEMENT: RESIDENT PROJECT REPRESENTATIVE SERVICES FOR
16 THREE RIVERS FILTRATION PLANT UV DISINFECTION PROJECT RES.
17 #2304-2010, W.O. #65942 by and between DLZ INDIANA, LLC and the City
18 of Fort Wayne, Indiana, in connection with the Board of Public Works, is
19 hereby ratified, and affirmed and approved in all respects, respectfully for:

20 All labor, insurance, material, equipment, tools, power,
21 transportation, miscellaneous equipment, etc., necessary for
22 Resident Project Representative (RPR) services during
23 construction that include coordination with plant activities and
24 staff, daily inspections, construction schedule management and
25 coordination, construction progress meetings, administrative
26 duties, coordination of training services, record drawing review,
27 and other general construction management tasks. In addition,
28 the EPA Long Term 2 Enhanced Surface Water Treatment Rule
29 requires project record documentation as well as compliance
30 with mandatory deadlines;

involving a total cost of FIVE HUNDRED SIXTY-TWO THOUSAND, THREE
HUNDRED AND 00/100 DOLLARS - (\$562,300.00).
