SPECIAL ORDINANCE NO. S- 16-12

AN ORDINANCE approving the awarding of ITB #3435-PURCHASE OF CONCRETE/CEMENT by the City of Fort Wayne, Indiana, by and through its Department of Purchasing and IRVING READY MIX for the WATER POLLUTION CONTROL/STORMWATER MAINTENANCE DEPARTMENTS AND WATER MAINTENANCE AND SERVICE DEPARTMENT.


