AN ORDINANCE approving GRISWOLD LIFT STATION IMPROVEMENTS - RES. #2414-2011, W.O. #75230 between R.G. ZACHRICH CONSTRUCTION and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the GRISWOLD LIFT STATION IMPROVEMENTS - RES. #2414-2011, W.O. #75230 by and between R.G. ZACHRICH CONSTRUCTION and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for conversion of the existing lift station into a submersible pump lift station by selective demolition of the existing building, mechanical and electrical equipment; construction of a new top slab and valve vault; installation of new pumps, valves, plumbing and electrical equipment:

involving a total cost of FOUR HUNDRED TWENTY-THREE THOUSAND, TWO HUNDRED FIFTY AND 00/100 DOLLARS -(\$423,250.00). A copy said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.
