17 with the Board of Public Works, is hereby ratified, and affirmed and approved
18 in all respects, respectfully for:

19 All labor, insurance, material, equipment, tools, power,
20 transportation, miscellaneous equipment, etc., necessary for
21 Installation of two (2) 2,500-gallon per minute pumps,
22 starters, variable frequency drive, wiring, instrumentation,
23 controls, and appurtenances at Pump station 1;
24 instrumentation, controls and appurtenances at Pump
25 Station 2 and Coldwater Tank, all in accordance with the
26 Bidding Documents and Drawing Sheets, Pages 1 through
27 23 and prepared by HNTB Corporation;

28 involving a total cost of SIX HUNDRED EIGHTY-THREE THOUSAND, NINE
29 HUNDRED AND 00/100 DOLLARS - (\$683,900.00). A copy said Contract is
30 on file with the Office of the City Clerk and made available for public
inspection, according to law.
