11 **OF THE CITY OF FORT WAYNE, INDIANA;**


12 **SECTION 1.** That ITB #3515-ANNUAL CONTRACT FOR THE

18 asphalt and used for the construction and maintenance of city
19 streets including paving, chip and seal resurfacing, and crack
20 sealing. Asphalt is also used for patching potholes and utility cut
21 restorations;


22 involving a total cost of NINE HUNDRED THOUSAND DOLLARS -
