4 AN ORDINANCE of the Common Council fixing,
5 establishing and ratifying compensation for certain
6 City employees represented by The Fraternal Order
7 Police, Indiana Wayne Lodge #14, Inc.

8 **WHEREAS**, Common Council previously passed Special Ordinance No.S-130-
9 09 approving the collective bargaining agreement for employees of the City of Fort Wayne,
10 Indiana, represented by The Fraternal Order Police, Indiana Wayne Lodge #14, Inc.; and

11 **WHEREAS**, said agreement is for three (3) years, but pursuant to Indiana law,
12 the compensation provided for therein must be annually ratified; and

13 **WHEREAS**, this ordinance is necessary to ratify, fix and establish such
14 compensation increased by one percent (1%) for the year 2011 (retroactive to January 1, 2011)
15 for said employees of the City of Fort Wayne, Indiana represented by The Fraternal Order
16 Police, Indiana Wayne Lodge #14, Inc..

17 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF
18 THE CITY OF FORT WAYNE, INDIANA:**

19 **SECTION 1.** The 2011 Wage Agreement by between The Fraternal Order
20 Police, Indiana Wayne Lodge #14, Inc. and the City of Fort Wayne, a copy of which is on file in
21 the Office of the City Clerk and available for public inspection, is hereby approved and ratified in







The annual base salary of Sergeants and Lieutenants shall be increased by one (1) percent retroactive to January 1, 2011.






