12 **SECTION 1.** That THE EDGEWATER AVENUE LEVEE
13 REPAIR PROJECT - BOARD OF WORKS RESOLUTION #3779N mandated
14 by the UNITED STATES ARMY CORP OF ENGINEERS and the City of Fort
15 Wayne, Indiana, in connection with the Board of Public Works, is hereby
16 approved in all respects, respectfully for:

17 Approval of The Edgewater Avenue Levee Repair Project to
18 extend from Tecumseh Street Bridge southwest 1,163 feet
19 or roughly 187 feet west of Dearborn Street. Necessary
20 repairs will be made to the Edgewater Avenue Levee as
21 created by erosion and scouring and mandated by the
22 United States Army Corp of Engineers. Construction budget
23 for the project will include all the labor, insurance, material,
24 equipment, tools, power, transportation, miscellaneous
25 equipment, etc. necessary to complete The Edgewater
26 Avenue Levee Repair Project:

27 involving a total construction project budget cost of SIX HUNDRED TWENTY
28 THOUSAND AND 00/100 DOLLARS - (\$620,000.00).


