
9 **SECTION 1.** That RFP #3415-PROJECT 25 RADIO SYSTEM FOR

14 The Project 25 trunked radio system shall permit the radio user
15 to roam across the entire area of coverage without requiring
16 manual switching or changing of site information. RFP #3415
includes all radio system hardware, software, tower sites, 911
17 center and radio equipment for the end users;

18 Involving the City's portion of the project cost of NINE MILLION, EIGHT
19 HUNDRED TWENTY-SIX THOUSAND, TWO HUNDRED SEVENTY-SEVEN
20 AND 00/100 DOLLARS - (\$9,826,277.00) – (total cost of the system is
21 \$16,986,484.00) all as more particularly set forth in said RFP #3415-
22 PROJECT 25 RADIO SYSTEM which is on file in the Office of the Department
