24 MILES IN THE 2ND DISTRICT; 1.64 MILES IN THE 3RD
25 DISTRICT; 1.34 MILES IN THE 4TH DISTRICT; 1.39
26 MILES IN THE 5TH DISTRICT; AND 1.34 MILES IN THE
27 6TH DISTRICT;

28 involving a total cost of EIGHT HUNDRED EIGHTY-SEVEN THOUSAND,
29 FIVE HUNDRED EIGHTY-TWO AND 55/100 DOLLARS - (\$887,582.55). A
