18 transportation, miscellaneous equipment, etc., necessary for  
19 "2012 CIPP PKG #2 - SMALL DIAMETER":  
20 REHABILITATION OF APPROXIMATELY 48,664 LF OF  
21 SMALL DIAMETER (8-INCH TO 15-INCH) SANITARY AND  
22 COMBINED SEWER BY MEANS OF CURED-IN-PLACE  
23 PIPE METHOD:

24 involving a total cost of ONE MILLION, FIVE HUNDRED FORTY-THREE  
25 THOUSAND, FOUR HUNDRED THIRTY-FOUR AND 80/100 DOLLARS -  
26 (\$1,543,434.80). A copy said Contract is on file with the Office of the City
