19 2012 CIPP PKG #1 - MEDIUM DIAMETER – Rehabilitation  
of approximately 12, 177 LF of medium diameter (18-inch to  
30-inch sanitary and combined sewer by means of a cured-  
in-place pipe method:


20 involving a total cost of ONE MILLION, ONE HUNDRED FORTY-TWO  
21 THOUSAND, EIGHT HUNDRED SEVENTY-EIGHT AND 00/100 DOLLARS -  
22 (\$1,142,878.00). A copy said Contract is on file with the Office of the City  
23 Clerk and made available for public inspection, according to law.

24 **SECTION 2.** That this Ordinance shall be in full force and effect  
25 from and after its passage and any and all necessary approval by the Mayor.
