10 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON
11 COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

12 **SECTION 1.** That the CONSTRUCTION CONTRACT FOR
13 FAIRFAX STORM SEWER EXTENSION - RES. #2420-2011, W.O. #75663
14 by and between FLEMING EXCAVATING, INC. and the City of Fort Wayne,
15 Indiana, in connection with the Board of Public Works, is hereby ratified, and
16 affirmed and approved in all respects, respectfully for:

17 All labor, insurance, material, equipment, tools, power,
18 transportation, miscellaneous equipment, etc., necessary for
19 This project will consist of a storm sewer extension that will
20 be along Fairfax Avenue from South Wayne Avenue to Old
21 Mill Road and regulator modifications to the Woodhurst
22 Regulator. This will consist of approximately 1350 lf of 68" x
23 43" RCP and 265 lf of 54", 48", 42", 36", 30" & 12" RCP.
24 The storm extension will pick up an existing storm sewers
25 system with inlets and catch basins that are currently
26 connected to the combined system. The project will also
27 consist of 780 lf horizontally directional drilled (HDD) water
28 main replacement on Fairfax Avenue from South Wayne
29 Avenue to Woodhurst Boulevard:

30 involving a total cost of ONE MILLION, TWO HUNDRED FIFTEEN
THOUSAND, EIGHT HUNDRED NINETY-EIGHT AND 87/100 DOLLARS -
(\$1,215,898.87). A copy said Contract is on file with the Office of the City
Clerk and made available for public inspection, according to law.


