5 CONTRACT FOR IMPROVEMENT RESOLUTION  
6 NO. 3779N - EDGEWATER AVENUE LEVEE  
7 REPAIR - WORK ORDER 3779N between T-E  
8 INC and the City of Fort Wayne, Indiana, in  
9 connection with the Board of Public Works.

10 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**  
11 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

12 **SECTION 1.** That the CONSTRUCTION CONTRACT FOR  
13 IMPROVEMENT RESOLUTION NO. 3779N - EDGEWATER AVENUE  
14 LEVEE REPAIR - WORK ORDER 3779N by and between T-E INC and the  
15 City of Fort Wayne, Indiana, in connection with the Board of Public Works, is  
16 hereby ratified, and affirmed and approved in all respects, respectfully for:

17 All labor, insurance, material, equipment, tools, power,  
18 transportation, miscellaneous equipment, etc., necessary for  
19 The Edgewater Avenue Levee Repair starts at the  
20 Tecumseh Street bridge and extends west approximately  
21 1200 lineal feet. This project requires final clearing of  
stumps and vegetation to ground level, compacting of three  
feet of clay on the slope, placing a rip rap toe at the river  
edge, covering the clay with 4" topsoil, seeding the slope,  
adding straw matting and placing Scour Stop:

22 involving a total cost of EIGHT HUNDRED THIRTEEN THOUSAND, FIFTY-  
23 ONE AND 00/100 DOLLARS - (\$813,051.00). A copy said Contract is on file  
24 with the Office of the City Clerk and made available for public inspection,  
25 according to law.
