18 THOUSAND, FIVE HUNDRED NINETY-ONE AND 00/100 DOLLARS –
19 (\$1,214,591.00) all as more particularly set forth in said ITB #3533 - ASH
20 TREE REMOVAL FOR 2012 which is on file in the Office of the Department of
21 Purchasing, and is by reference incorporated herein, made a part hereof, and
22 is hereby in all things ratified, confirmed and approved.


