2 **SPECIAL ORDINANCE NO. S-39-13**

3 AN ORDINANCE of the Common Council extending the
4 Collective Bargaining Agreement for 2010-2012 for one (1)
5 year and fixing, establishing and ratifying compensation for
6 certain City employees represented the CHAUFFEURS,
TEAMSTERS, AND HELPERS LOCAL NO. 414 – WATER
POLLUTION CONTROL MAINTENANCE PLANT.

7 **WHEREAS,** Common Council previously passed Special Ordinance No.S-111-
8 10 approving the three (3) year (2010 – 2012) collective bargaining agreement for
9 employees of the City of Fort Wayne, Indiana, represented by the CHAUFFEURS,
10 TEAMSTERS, AND HELPERS LOCAL NO. 414 – WATER POLLUTION CONTROL
MAINTENANCE PLANT; and

11 **WHEREAS,** the City and the CHAUFFEURS, TEAMSTERS, AND HELPERS
12 LOCAL NO. 414 – WATER POLLUTION CONTROL MAINTENANCE PLANT, have
13 agreed to a one (1) year extension of the 2010-2012 Collective Bargaining
14 Agreement including all existing Memoranda Agreements and Letters of Agreement;
and

15 **WHEREAS,** pursuant to Indiana law, the compensation provided for therein
16 must be annually ratified; and

17 **WHEREAS,** this ordinance is necessary to ratify, fix and establish such
18 compensation increased by two percent (2%) for the year 2013 for said employees of
19 the City of Fort Wayne, Indiana represented by the CHAUFFEURS, TEAMSTERS,
20 AND HELPERS LOCAL NO. 414 – WATER POLLUTION CONTROL MAINTENANCE
PLANT retroactive to January 1, 2013.

22 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL**
23 **OF THE CITY OF FORT WAYNE, INDIANA:**

24 **SECTION 1.** The one (1) year extension of the 2010-2012 Collective Bargaining
25 Agreement by and between the CHAUFFEURS, TEAMSTERS, AND HELPERS
26 LOCAL NO. 414 – WATER POLLUTION CONTROL MAINTENANCE PLANT,, and
27 the City of Fort Wayne, a copy of which is on file in the Office of the City Clerk and
28 available for public inspection, is hereby approved and ratified in all respects.
