8 **WHEREAS**, on December 18, 2012, the Common Council of the City of Fort
9 Wayne passed Special Ordinance No. S-132-12 which established
10 the City of Fort Wayne Community Trust Fund; and,

11 **WHEREAS**, the Common Council of the City of Fort Wayne and the Mayor
12 believe the funds should henceforth be distributed for purposes and
13 activities determined to be in the public interest according to duly
14 enacted resolutions of the Common Council of the City of Fort
15 Wayne; and,

16 **WHEREAS**, the guiding principles refer to these funds as Legacy funds to be
17 used for transformational investment and to leverage additional
18 resources.


19 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
20 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

21 **SECTION 1.** The City of Fort Wayne Community Trust Fund shall be
22 renamed as The City of Fort Wayne Community Legacy Fund.

23 **SECTION 2.** That this Ordinance shall be in full force and effect from
24 and after its passage and any and all necessary approval by the Mayor.
