NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:


SECTION 1. That Section 3. of Special Ordinance No. S-84-13 is amended to reflect the following changes:
