

Re: 2014 New Street Sweeper for Street Department

In regards to a New 2014 three wheel street sweeper for the Street Department, please award to Brown Equipment for a total cost of \$167,500 for a New/demo 2013 Global/Allianz, a model MX3 Brown Equipment is the dealer for this type of equipment. Unit has 42 hours and 135 miles on unit full two year warranty. This would be a proprietor and a special purchase for this model and type of street sweeper. The Street Department has seven street sweepers of this type and style. This would be a replacement for an older machine the city is currently using a 2000 (City ID #80029) with over 10,000 hours on unit.

Reason for being a proprietor is center cab, single steering wheel, better pedestrian safety with front steer, mechanical pickup (works best in leaf season), can sweep in the same direction of traffic against the curb.

An evaluation sheet was done by sweeper operator's documenting their likes and dislikes. We also had a group meeting so operators could voice their opinions regarding which unit would be best to do their job. Global/Allianz was the unit the operators like the best. The City currently has seven other Global/Allianz type street sweeper's and they have been very good pieces of equipment for the City. The operators would also be able to run the new equipment immediately because the units would be the same type controls. City Operator's like the front steer and visibility of the Global/Allianz sweepers the best!

Checked with Brown Equipment on pricing of a New unit \$190,000 in 2014 after price increase the first of the year City of Fort Wayne purchased a new unit in 2013 and paid \$175,000 for the same type of machine

Checked with the other National and state purchasing agreements for a comparable cost and was substantial higher.

Your consideration and approval for this purchase request is greatly appreciated.

The delivery time is 30 days.

Brown Equipment is registered as a Buy Indiana company and a local company in Fort Wayne.
