SECTION 1. That the CONSTRUCTION CONTRACT - 2014 - RESURFACING PACKAGE B by and between WAYNE ASPHALT and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for milling and resurfacing package focuses on various streets in the Northeast Quadrant of the City. Approximately eight (8) centerline miles of roadway are represented in this package. All locations will experience surface or surface and intermediate course replacement, some pavement markings, signal loop work, castings and valves adjusted to grade:
