AN ORDINANCE approving CONSTRUCTION CONTRACT - SOUTHWICK VILLAGE CONCRETE STREET REPAIRS between KEY CONCRETE, INC. and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CONSTRUCTION CONTRACT - SOUTHWICK VILLAGE CONCRETE STREET REPAIRS by and between KEY CONCRETE, INC. and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for removal and replacement of approximately 21,777 SY of concrete pavement for streets. Project also includes affected residential drives, corner wingwalks & ramps, sidewalk and lawn restoration:

involving a total cost of EIGHT HUNDRED FIFTY-SEVEN THOUSAND, SEVEN HUNDRED SEVENTY-FIVE AND 50/100 DOLLARS - (\$857,775.50). A copy of said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.


