12 purchases made to their benefit; and


13 Whereas, the City of Fort Wayne and Allen County have met

17 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**


18 **SECTION 1.** That the payment of fund to Allen County for the
