NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CONTRACT FOR LIME MACHINES CONTROL IMPROVEMENTS - RES. #66460, W.O. #66460 by and between RS TECHNICAL SERVICES, INC. and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for Lime Machines Control Improvements at Fort Wayne's Three Rivers Filtration Plant; - purchase and replacement of PLC's and HMI's at the water filtration plant that control the lime softening chemical feed system:

involving a total cost of ONE HUNDRED ONE THOUSAND SIX HUNDRED FORTY AND 00/100 DOLLARS - (\$101,640.00). A copy of said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.



Please find attached to this letter RS Technical Services, Inc.'s quote CO 11162 to replace the controllers (PLCs) and operator interfaces (HMIs) in Fort Wayne Water Treatment Plant's six existing Wallace & Tiernan Lime Slaker Control Panels. RS Technical Services' comments about this quote follow below. RS Technical Services' references and a statement regarding RSTS' status as the W&T Lime Slaker manufacturer's only authorized service contractor are also attached to this letter.

The new quote is slightly higher than the August 2014 estimate because we changed the PLC processor and HMI PanelView – both of which were more expensive than the items originally quoted.

RS Technical Services' quote shows the price per control panel and includes the following materials:

- (1) Allen Bradley 1769-L33ER CompactLogix processor with version 20.xx firmware
- (1) Allen Bradley 1769-PA4 CompactLogix PLC power supply
- (1) Allen Bradley 1769-IA16 CompactLogix digital AC input module
- (1) Allen Bradley 1769-OA16 CompactLogix digital AC output module
- (1) Allen Bradley 1769-IF4I CompactLogix isolated analog input module
- (1) Allen Bradley 1769-OF4CI CompactLogix isolated analog output module
- (1) Allen Bradley 1769-ECR CompactLogix end cap
- (1) Allen Bradley 2711PC-T10C4D8 PanelView Plus 6 Compact terminal, 10" color touch screen
- (1) Allen Bradley 4983-DC120-05 line filter and surge protector
- (1) Allen Bradley 1606-XLE120E power supply
- (1) Allen Bradley 1783-US5T Stratix 2000 unmanaged 5-port copper ethernet switch
- (1) LOT: DIN rail, wire, network cables, ID labels and installation hardware (fasteners)

RS Technical Services' price includes the following labor:

- Generate new control panel drawings and wiring diagrams showing the new equipment. The price includes one printed copy of as-built/record drawings for each control panel and two additional printed copies. Digital copies of the drawings, all programming and startup reports will also be provided on CD/DVD.
- Remove and replace the existing six W&T Lime Slakers' PLCs and HMIs with the above equipment.

- Program all six PLCs and six HMIs as necessary to startup and put Fort Wayne WTP's six Lime Slakers back into operation with the new controls.

RS Technical Services' quote line 2 includes all of the above labor and materials except that we replaced the Allen Bradley 2711PC-T10C4D8 PanelView Plus 6 Compact terminal with one Allen Bradley 2711P-T10C4A8 PanelView Plus 6 terminal, 10" color touch screen which costs significantly more than the Compact model. Fort Wayne WTP might want to go with the more expensive PanelView for a couple reasons:

- (1) You are standardizing on the same PanelView throughout your plant and so are simplifying spare parts and programming; or
- (2) You require the PanelView "remote desktop" access and file editing software features offered on the more expensive PanelView.

Jim Fort mentioned in a recent phone conversation that Fort Wayne WTP intends to integrate the Lime Slaker control panels into a larger SCADA System. As such, a centralized SCADA Computer (Historian Server) might be a better place to invest money in added memory / storage for long term historical trending rather than investing in an expensive PanelView HMI on each Lime Slaker Control Panel.

We estimate it will take one technician about two to three days per lime slaker to complete the PLC and HMI change-out. We would work on one slaker at a time. After talking with some of your staff (John Weirick) at the Rockwell Automation On The Move Trade show in Grand Rapids, MI last summer and with Jim Fort a few days ago, it sounds like taking one slaker down at a time for controls upgrades would be acceptable since Fort Wayne WTP does not run all six slakers simultaneously. Please advise if this is not the case.

We assumed that the six existing lime slaker control panels are identical. Additional programming labor may be needed if the control panels differ.

Thank you for this opportunity to bid.

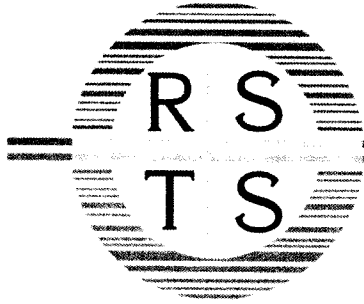



The slaker is controlled by a Programmable Logic Controller (PLC). The existing PLC's for the six (6) slaking machines are no longer supported, and parts are difficult and expensive to obtain. This project will install new PLC and Human Machine Interface (HMI) equipment on each slaker so that the Plant can ensure these machines run efficiently and reliably for years to come.
