AN ORDINANCE approving the awarding of I.T.B. #3372 - PURCHASE AND PLANTING OF STREET TREES FOR 2015 by the City of Fort Wayne, Indiana, by and through its Department of Purchasing and SHADE TREES UNLIMITED INC. for the FORT WAYNE PARKS AND RECREATION DEPARTMENT.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA;

SECTION 1. That I.T.B. #3372 - PURCHASE AND PLANTING OF STREET TREES FOR 2015 between the City of Fort Wayne, by and through its Department of Purchasing and SHADE TREES UNLIMITED INC. for the FORT WAYNE PARKS AND RECREATION DEPARTMENT, respectfully for:

purchase of trees to be planted in the City right-of-way and parks. This is the 5th year of a 5-year contract;

involving a total cost of ONE HUNDRED SIXTY-ONE THOUSAND, FIVE HUNDRED EIGHTY-FIVE AND 00/100 DOLLARS - (\$161,585.00) all as more particularly set forth in said I.T.B. #3372 - PURCHASE AND PLANTING OF STREET TREES FOR 2015 which is on file in the Office of the Department of Purchasing, and is by reference incorporated herein, made a part hereof, and is hereby in all things ratified, confirmed and approved.



If this contract does not get approved then over four hundred property owners who have requested and paid for trees will not be served. Their co-payments will all have to be refunded. Trees will also not be planted in recently developed neighborhoods. The replacements for the trees that did not live from last year's planting efforts will not be planted. The replacement for all of the ash trees lost will not be planted as well. If we discontinue the planting of trees the overall aesthetic beauty and quality of our city will diminish.</u></p>
