SPECIAL ORDINANCE NO. S-93-16

AN ORDINANCE of the Common Council fixing, establishing and ratifying compensation for police officers represented by the Fraternal Order of Police, Indiana F.O.P. Labor Council, Inc. for the year 2017.

WHEREAS, this Council is required to approve all collective bargaining decisions with regard to annual pay and monetary fringe benefits; and

WHEREAS, such compensation for police officers of the City of Fort Wayne, Indiana, represented by the Fraternal Order of Police, Indiana F.O.P. Labor Council, Inc. has been arrived at pursuant to agreements reached by and between the City and the Fraternal Order of Police, Indiana, F.O.P. Labor Council, Inc. in accordance with collective bargaining as authorized and envisioned by City ordinances; and

WHEREAS, said agreement is for three (3) years, but pursuant to Indiana law, the compensation provided for therein must be annually ratified; and

WHEREAS, the Common Council desires to express its approval of the fiscal portions of the agreement and the compensation package for the year 2017; and

WHEREAS, this ordinance is necessary to ratify, fix and establish such compensation for said police officers represented by the
