

I. **HOT OIL HEATER:** An ALmix Model HC-150 helical coil type heater with 1,500,000 BTU/HR output capacity is provided to heat the liquid asphalt storage system. The fully automatic unit is complete with heat exchanger, circulating pump, burner, expansion tank, manifold and control system. The helical coiled tube heat exchanger provides for a controlled flow design of maximum thermal efficiency. The coil is schedule 40 seamless pipe close wound and welded. The coil is placed in the heater so that it can expand and contract without fatigue cracking. The last two turns are spaced approximately one inch apart to allow for thermal expansion. The burner fires down the center of the coil with the combustion gases travelling the full length of the coil. The hot gases make a return pass over the outside of the coil and exhaust through the stack at the burner end of the heater. This 12 in. diameter stack includes rain cap with screen and high temperature limit control. The shell of the heater is fabricated from 3/16" steel plate and is lined with 2" thick high temperature ceramic fiber blanket. Front and rear doors provide access to the coil. The rear door includes a sight glass for viewing the flame pattern. The heater and all components are skid mounted. The 80 gal. expansion tank is provided mounted, piped and wired to the heater shell. The expansion tank includes two lines with valves piped to the tank for purging the system during startup. The expansion tank also includes low oil cut off and sight level gauge. The



low oil level control is mounted on the expansion tank and set so that the tank must be filled to the quarter full level. A glass sight gauge is furnished for visual checking. The Powerflame NATURAL GAS burner utilizes the lo-hi-lo firing mode. The burner includes 1/2 H.P. blower, electric spark ignition, on/off firing with automatic air control, control transformer, lo-fire switch, Fireye control flame detection system with flame failure bell, fuel pump and first out annunciator. The "first out" annunciator for trouble shooting has lights to indicate the location of a problem. Each light is connected to the interlock circuit being monitored. The following circuits are monitored:

1. low fire limit control
2. stack temperature safety limit
3. low oil level
4. heater hot oil pump motor interlock
5. high temperature oil safety limit

The system oil temperature control consists of an indicating dial control for regulating the desired temperature. Low oil cut off prevents operation of the burner until the proper oil level is achieved. A high temperature control shuts the burner off automatically in the case of high oil temperature. A high limit stack temperature control shuts off the burner automatically in the case of high stack temperature. A low pressure switch shuts off the burner automatically in the case of a drop in pressure on the input side of the coil. The oil circulating system includes one (1) circulating pump driven by a 5 H.P., 3/60/460v motor, Y-strainer, expansion tank with gauge glass assembly, thermometer and pressure relief valve.

#### **I. DRAG CONVEYOR**

A. GENERAL: The 20" wide x 58' long drag type conveyor is driven by 30 H.P., 1800 RPM, 3/60/460V motor through a shaft mounted Dodge TXT 725 speed reducer. The drag chain is 2268, 4.04" pitch roller type, having alloy steel side bars, carburized bushings, case hardened pins and hardened rollers. The conveyor operates at approximately a fifty (50) degree incline for high efficiency and low abrasion. The head sprocket consists of a heat treated segmental ring which bolts to a hub assembly having a taper lock bushing for positive locking to the 3-15/16" diameter head shaft. The conveyor bottom is fitted with 1/2" thick Hardox 400 alloy plate liners and the sides are fitted with 3/8" thick Hardox liners. A by-pass chute actuated by a 4" diameter air cylinder allows direct loading of trucks. The drag conveyor is supported by Purchaser's existing structure. An air cylinder operated 3,000 lbs. slug feeder is suspended from the drag conveyor to allow the direct loading of trucks. Purchaser's existing electrical equipment shall be utilized to operate the new drag conveyor.

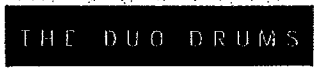

Description of Project (Be Specific):

According to the manufacturer, this plant had an expected lifespan of 10-15 years. Through a combination of preventive maintenance and timely repairs we have been able to operate our plant for 18 years. At this time we are faced with conditions that warrant a more extensive overhaul to continue producing asphalt for use by the Street Department on City Infrastructure. Our seasoned operators and the manufacturer have both suggested only two options, repair the existing plant or purchase a new plant. If we pursue the option to repair/overhaul the existing plant, the City should expect another 10-15 years of operation. This is consistent with the life expectancy of a new plant. However, the purchase of a new plant would be six to seven times more expensive while netting us no gains in expected usable life.


What Are The Implications If Not Approved:

Our asphalt plant provides us the ability to resurface up to 15 miles of streets per year. If the plant goes down, we will have to purchase asphalt from outside vendors at market prices. This would have a significant impact on our asphalt capital program.

If Prior Approval Is Being Requested, Justify: N/A

Additional Comments:

The repairs consist of the purchase of five major components (Hot Oil Heater, Drum, Trunnions, Drag Conveyor, Burner) and onsite installation. The Street Department has funds available to pursue this purchase in 2016. The Street Department performed asphalt overlays for 2016 which required fewer tons of asphalt. The savings are enough to cover the proposed repairs and installation. No additional appropriation will be required.
