8 122-12 (attached hereto and made a part hereof) approving City of Fort
9 Wayne and Allen County jointly operating computer systems and
10 networks to benefit of all City and County departments;

11 **WHEREAS**, due to increased computer usage in City Utilities
12 related to an improved billing system and mobile technology, an
13 additional THREE HUNDRED FIFTY THOUSAND AND 00/100
14 DOLLARS – (\$350,000) will be needed for the remainder of the current
agreement for computer services.


15 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**

AN ORDINANCE approving the purchase for three years (2014, 2015, 2016) of Computer Services for the separate and shared infrastructure utilized by the City of Fort Wayne and Allen County for an annual cost to the City of \$2,503,392 and a total cost of \$7,510,176; from and through Atos IT Solutions and Services by the City of Fort Wayne, Indiana,

Whereas, the City of Fort Wayne and Allen County jointly operate computer systems and networks to benefit of all City and County departments;

Whereas, the City and County have jointly service providers for shared computing infrastructure since 1988;

Whereas, the City and County have an negotiated a three year contract extension that maintains a flat services rate for term of the contract and provides a significant reduction in the cost of project services;

Whereas, the City of Fort Wayne and Allen County wish to jointly contract and share the cost of an IT services through Atos IT Solutions and Services to manage the networks, applications, systems, and hardware currently running in our environment.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:


