
NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

The purchase of LED Acorn style fixtures to replace High Pressure Sodium fixtures throughout the City of Fort Wayne:



Description of Project (Be Specific):

Purchase of LED Acorn style fixtures to replace High Pressure Sodium fixtures (HPS). The LED fixtures are more energy efficient and require little maintenance and come with a 7 year warranty. The quality of the light is also more superior with the LEDs. We have standardized the light fixtures in the downtown and fringe areas and will be going to this style of fixture as funding becomes available or as we make roadway improvements that include street lighting. The fixture is manufactured by Sternberg and is distributed in our region by ESL Spectrum Inc.


What Are The Implications If Not Approved:

As we make progress in changing out our street light inventory from HPS to LED, we will continue to yield cost savings in energy consumption as well as maintenance (i.e. bulb changes/outages). These LEDs are warranted for 7 years and require minimum maintenance. With 34,000 street lights in our inventory, we look for funding sources to make this transition happen.

If Prior Approval Is Being Requested, Justify: N/A

Additional Comments:

Community Development has agreed to fund up to \$80,000 in these LED fixture replacements. These replacements are to be made along the Broadway business corridor. We have also replaced several Acorn fixtures with LEDs in the downtown and abutting areas. Since we will be exceeding the \$100,000 threshold for a sole source provider, we are seeking Council approval.
