replacement of flooring in the McMillen Park Community Center; involving a total cost of TWO HUNDRED TWENTY-SIX THOUSAND FOUR HUNDRED FIFTY AND 00/100 DOLLARS - (\$226,450.00) all as more particularly set forth in said ITB #4086 - CONTRACT FOR REPLACEMENT OF FLOORING AT MCMILLEN PARK which is on file in the Office of the Department of Purchasing, and is by reference incorporated herein, made a part hereof, and is hereby in all things ratified, confirmed and approved.


